This Statement **AND ALL** accompanying Worksheet(s) are to be completed and filed by each well Owner/Operator of a water-producing facility located within the boundaries of the Santa Ynez River Water Conservation District. **CALIFORNIA WATER CODE REQUIRES ALL PRODUCERS TO REPORT GROUNDWATER PRODUCTION AND PAY GROUNDWATER CHARGES.** To avoid late fees, signed original Statements with Worksheets and payment should be filed by **JANUARY 31, 2021**. Groundwater filings postmarked after that date are considered delinquent and will incur a 10% penalty charge and a 1% interest charge per month or portion thereof.

INSTRUCTIONS: *First*, complete each of the enclosed Worksheet(s) to calculate water production by water type. *Next*, complete this Statement. From **ALL** Worksheet(s), transfer the total acre-feet produced from all wells, by water type, to this Statement, Column (A) Lines 1 through 3. Multiply the acre-feet in Column (A) by the charge per acre-foot in Column (B) and enter the result as groundwater charge in Column (C). Add Lines 1C, 2C and 3C and enter total in Line 4C. If applicable, calculate and enter penalty in Line 5C and interest in Line 6C. If there are prior credits or charges due, the amount will be shown in Line 7C. Add Lines 4C through 7C and enter the total amount due in Line 8C. Sign and complete the bottom section. *Next*, attach the **original** Worksheet(s) showing the acre-feet calculations to this **original** Statement. **Statements, Worksheets and payment are ALL required for filings to be complete. Retain the yellow carbon copies of all forms for your records.**
