BE IT RESOLVED AS FOLLOWS:

WHEREAS, on the 10th day of October, 1939, an election was held, pursuant to law and the order of this Board of Supervisors, and pursuant to due and legal notice by posting and by publication as required by law and the said order of this Board of Supervisors, in the proposed Santa Ynez River Water Conservation District hereinafter described, to determine the question whether such proposed district should or should not be organized and also to elect five directors, and

WHEREAS, this Board of Supervisors has this 23rd day of October, 1939, being the first meeting of said Board of Supervisors at which this matter could legally be considered, regular, general or special, held after said election, canvassed the returns of said election, and found and ascertained that the total number of votes cast at said election was 697; that of said total vote cast 626 were "Water Conservation District - Yes" and 71 were "Water Conservation District No"; and that a majority of all votes cast were and are "Water Conservation District - Yes" and in favor of the organization of said proposed district.

Now, Therefore, it is hereby Resolved, Ordered and Declared that all of the territory above mentioned within the boundaries of the said Santa Ynez River Water Conservation District as fixed by the order of this Board and hereinafter described be, and the same hereby is duly organized as a Water Conservation District under the name of "Santa Ynez River Water Conservation District" under the provisions of an act entitled "An Act to provide for the creation, organization and government of water conservation districts, defining their powers, and prescribing the method of exercising the same, re-enacting and continuing in force the provisions of Chapter 166 of the Statutes of 1929, known as the "Water Conservation Act of 1929" and validating and confirming all proceedings had and taken under the provisions of said Act resulting in the organization of water conservation districts and continuing such districts under the provisions of this act with the powers herein conferred*, said act being approved June 16, 1931, being Chapter 1020 of the Statutes of 1931, pages 2045 to 2068 inclusive, as said act was amended and revised by Chapter 906 of the Statutes of 1933, pages 2348 to 2361 inclusive, and by Chapter 473 of the Statutes of 1937, pages 1420 to 1423 inclusive.

The territory above mentioned and which is hereby declared to be organized as such Water Conservation District is situated in the County of Santa Barbara, State of California, and is bounded and described as follows, to wit:

And Whereas, it appears from said canvass that said Thomas M. Parks, William Hubbard Cooper, Robert Hibbits, Robert J. Batty, and Henry George Petersen, have received respectively the highest number of votes for director from said respective divisions.

Now therefore, it is further Resolved, Ordered and Declared that Thomas M. Parks has been duly elected to the office of director of said Santa Ynez River Water Conservation District from Division Number One thereof; that William Hubbard Cooper has been duly elected to the office of director of said Santa Ynez River Water Conservation District from Division Number Two thereof; that Robert Hibbits has been duly elected to the office of director of said Santa Ynez River Water Conservation District from Division Number Three thereof; that Robert J. Batty has been duly elected to the office of director of said Santa Ynez River Water Conservation District from Division Number Four thereof, and that Henry George Petersen has been duly elected to the office of director of said Santa Ynez River Water Conservation District from Division Number Five thereof.

It is further Resolved, Found, Ordered and Declared that each and all of the proceedings requisite and necessary for legal organization of said District and election of each of said directors have been done and performed as required by law.
