#### Re: Request for EMA GSA Extension of Loan Repayment Terms

Dear Member Agency Representatives and Board of Directors,

On behalf of the Santa Ynez River Valley Groundwater Basin Eastern Management Area Groundwater Sustainability Agency (EMA GSA), I am writing to formally request that the Member Agencies provide written approval to postpone repayment of their Fiscal Year (FY) 2024 – 2025 EMA GSA contributions to FY 2027 – 2030. The original repayment terms in the EMA GSA Joint Exercise of Powers Agreement (JPA) called for repayment after December 2026. Therefore, written approval from your agency is needed to extend the payback period.

The repayment would include the \$200,000 that the EMA GSA has received in Member Agency contributions, the additional \$200,000 that is currently being requested in Member Agency contributions, and interest accrued in accordance with the terms of Section 14.3 of the JPA. As stated in the Interim Cost Share Agreement, interest will begin accruing after December 2026 unless your agency indicates in writing that it elects to waive interest or extend the date upon which interest begins to accrue. Further details on the proposed repayment schedule are available in the Groundwater Extraction Fee Rate Study Report, which can be accessed on the EMA GSA website at <a href="EMA-SantaYnezWater.org">EMA-SantaYnezWater.org</a>.

Re: Request for Fiscal Year 2024/25 EMA GSA Contribution #2

Dear Member Agency Representatives and Board of Directors,

On behalf of the Santa Ynez River Valley Groundwater Basin Eastern Management Area Groundwater Sustainability Agency (EMA GSA), I am writing to formally request an additional \$200,000 in funding for continued operation of the EMA GSA. These funds, to be shared equally amongst your agencies (i.e. \$50,000 per agency), are necessary to ensure sufficient funding is available for continued operation of the EMA GSA prior to the implementation of a revenue generating fee and to address short-term cash flow challenges associated with the 2021 Sustainable Groundwater Management Grant Program SGMA Implementation Round 2 Grant pursuant to Proposition 68.

Your agencies' contributions to date have been instrumental in helping the EMA GSA achieve significant milestones, including approval of the Groundwater Extraction Fee Rate Study, release of a Proposition 218 Extraction Fee Notice, and adoption of a Well Registration Ordinance. If this current request is fulfilled, the EMA GSA will have received a total of \$400,000 in member agency contributions for Fiscal Year (FY) 2024/25.

Article 14.2(d) of the EMA GSA Joint Exercise of Powers Agreement sets forth the initial \$50,000 contribution from each agency, then notes that other financial contributions may be made by the agencies pursuant to the November 15, 2023 Interim Cost Share Agreement. Under Section 3 of the Interim Cost Share Agreement, activities that will be funded by these additional contributions must be outlined in a Task Order for the agencies' review with associated not-to-exceed dollar amounts plus ten percent contingency per activity. This Task Order is included below.
